Provide a K-2 system wide intervention program. I-ready will be used to screen and monitor progress. Title 1 interventionist, Literacy paraprofessionals and K-2 teachers will utilize various research-based programs to deliver intervention. Students will receive daily intervention and weekly progress monitoring. Universal screening will take place 3 times throughout the 2022-2023 SY.

A Title 1 reading interventionist will provide additional small group reading support to K-5 students. i-Ready Reading scores will be used to identify students. The reading interventionist will provide evidence-based instruction and progress will be monitored using i-Ready Reading. The title 1 reading interventionist will also supervise and support a Literacy interventionist and their daily intervention with students.

Description of how strategy/strategies will strengthen

Schumacher staff will utilize various literacy interventions based on the skill-based needs of students throughout our school. All staff will deliver research-based intervention through grade level intervention blocks. A title 1 interventionist will support students K-5 with research-based intervention. Literacy interventionist will meet daily with a caseload of students to deliver intervention and monitor progress throughout the school year.
